



Beltex Sheep Society Registration & Fees



Only fully paid up members can birth notify and register lambs, which belong to them. Lambs may be birth notified and registered via the on-line flock book available on www.beltex.co.uk or on the official forms available from the Society Office. If you need a form please call 015395 67973 or download one from the Beltex website.

Birth notification and registration rules and fees are as follows:

Birth Notification - Deadline: 31st May in the year of birth

- Submit registration form by 31st May (or in the month of birth for later-born lambs) along with the birth notification fee.
- ***Birth Notifications received in the office after the 31 May deadline (unless a late birth) the fee will automatically be doubled.***
- Birth notify all your lambs.
- You will be sent a list of the lambs you have birth-notified.

Please Note: All lambs to be entered at Society sales must be birth notified and full-pedigree registered before sale entries are submitted.

Full Pedigree Registration for Birth-Notified Lambs

Deadline: **28 February following year of birth**

- Copy of your list of notified lambs and a reminder to register will be sent to you in November/December.
- Decide which lambs should be fully registered, i.e. all lambs to be retained for breeding or for sale.
- Tick them off on your birth-notified list and send it back to the office with the Full Pedigree Registration fee.
- Pedigree certificates will be issued on payment of fees.

Please Note: All lambs to be entered at Society sales must be birth notified and full-pedigree registered before sale entries are submitted.

FEES:

- **Birth Notification** - received in the office by 31 May in year of birth
Submitted on Paper: £2.84 + VAT (£3.40)
Submitted Online via Pedeweb or Excel Spreadsheet: £2.00 + VAT (£2.40)

LATE Birth Notifications – received in the office after 31 May in year of birth (unless born after the 31 May)

Submitted on Paper: £5.68 + VAT (£6.80)

Submitted Online via Pedeweb or Excel Spreadsheet: £4.00 + VAT (£4.80)

- **Full Pedigree Registration of Birth Notified Lambs up to 28 February following year of birth**
Ram Lambs: £10.00 + VAT (£12.00)
Ewe Lambs: £8.00 + VAT (£9.60)

ET Lambs: - £15.00 + VAT (£18.00)

- Birth-notified lambs registered late ie over a year after birth, after 28 February: £20.00 + VAT (£24.00)
- Older animal registration: £50.00 +VAT (£60.00)

Import Fees – see Import Registration for full details

- Import Fee: £50.00 + VAT (£60.00)
Late Import Fee: £100 + VAT (£120)
Sale Levy: £100 + VAT (£120)

Lambs which are Embryo Transfers

- ET lambs must be birth notified on the normal forms available from the Society and must have the letters ET affixed to their name.
- The Beltex Sheep Society reserves the right to blood type.

Dual Registration

Any sheep registered with any other Society in the U.K will not be permitted to be registered with the Beltex Sheep Society. If sheep registered with the Beltex Society is registered elsewhere, it will immediately become de-registered with the Beltex Sheep Society. It will not be eligible for re-registration at any point in the future.
