38.2 Purchaser's rights

If the **Purchaser** proves a breach of warranty then, at the **Purchaser's** option, either the Purchaser may exercise his rights under Schedule 6, or the Vendor shall pay to the **Purchaser as Liquidated Damages** a sum equal to the amount in paragraph (i) of the Appendix. Notice of a claim must be supported by a **Veterinary Surgeon's Certificate** or a slaughterhouse manager's or other competent person's certificate confirming that the sheep was **In Lamb**.

39.1 Vendor's warranty

All sheep must be forwarded for penning and inspection between the following times 8am-9am.

ALL SHEEP FORWARD FOR SALE WILL BE INSPECTED AND SCANNED
UPON ARRIVAL TO THE MARKET

Pregnancy scanning – all sheep will be scanned at time of Inspection.

If any ewe or shearling ewe is found not to be in-lamb these will be rejected from the sale.

If any ewe lamb is found to be in-lamb these will be rejected from the sale.

General Sale Bye-Laws

1. All UK-bred sheep entered at Society sales must be fully registered and all fees paid prior to the Sale.
2. All tags must comply with UK legislation and Society rules on identification.
3. Substitutes must be declared to the Society and Auctioneers within the specified time stated on the sale entry form, and must be marked with a red dot on the loin.
4. Scrapie genotyping is voluntary. All sheep catalogued with scrapie genotype must have valid certificates.
5. The upset (minimum) price is 300gns at the Premier Sale. At all other Society sales, the upset price is 200gns.
6. Runs limited to 10, extra runs at end of the sale.
7. All sheep entered for Society sales must be inspected by a panel of inspectors appointed by the Society.
8. The inclusion of any animal in the show and/or sale following any inspection is no warranty that the particular animal meets any criteria or criterion in respects of any standards or will do so in the future.
9. Entry forms – Entries will be returned if certificates are not included.
10. Sale Ring Rule – Any sheep which has not passed Society inspection must not be offered for sale, or advertised or promoted, in the ring.
11. No animal to be sold outside of the ring before being entered in the sale ring.
12. Transfers – Any sheep to be sold at Society sales must be registered in the flock from which it is to be sold by 31st May in the year of sale.
13. Inspection – All sheep forward must be back-stamped with the lot number, failure to do so will result in rejection.
14. Any rams with semen retained before sale or females which have been flushed and embryos recovered before sale must be declared in the catalogue and announced at the time of sale. Failure to do so will result in the purchaser having the right to return the sheep. Costs may be incurred.
15. In Lamb & Empty Ewe Lamb Sale Rule - Recipients carrying pedigree embryos will be allowed to be sold at the in lamb female sales after fully registered sheep.
16. All sheep entered at In Lamb Sales to be scanned at time of Inspection.
17. Vendors balloted in the last 10 runs of shearling rams excluding any second runs, have the opportunity of withdrawing their total run and entry fees refunded. If the vendor opts to withdraw, they would forfeit the privilege ballot the following year.
18. Inspection – All sheep forward must be back-stamped with the lot number.

Inspections

19. Tags which do not comply with UK legislation and Society requirements will result in the sheep being rejected at inspection. From 2008 all registered lambs must carry tags with the Society logo. Check that tags are correct at time of entry, so that replacement tags can be ordered before the sale.
20. All sheep forward must be back-stamped with the lot number, failure to do so will result in rejection.
21. Sheep which have failed inspection will be identified by a neck tag marked 'Reject', or may be removed immediately from the market premises.
22. Rejected sheep which are to be penned with the rest of the consignment must be identified by a neck tag marked 'Reject'. It is a condition of entry that this rule is strictly adhered to. Vendors are advised to check their animals thoroughly prior to departure from home.
23. Inspection will include the following points: Teeth and Testicles, Mobility Udder, Muscularity and any other points deemed necessary by Council as they see fit.

26. Inspection Standards

- a. TEETH – To be inspected and assessed at the discretion of the inspector.
- b. MOBILITY – Sheep should be mobile and sound. Rams should be capable of natural service.
- c. TESTICLES - Should be of even size, move freely and be free of abnormalities.
- d. DOUBLE MUSCLING – Sheep should display double-muscled gigots.
- e. UDDER - Should be correct and free of abnormalities.
- f. FLEECE – Should be tight. A medium fleece may be acceptable.

27. Appeals

Appeals against an inspection decision may be made to the Chief Inspector or Society Secretary. A deposit of £50 (refundable if appeal is successful) must be lodged and the sheep will then be inspected by an appeals team of three people elected prior to the sale by Council. The decision of the appeals committee is final. Appeal to be lodged within 1 hour of the inspection decision.

29. Sales held under the auspices of the Society

All sheep sold at any sale held under the auspices of the Society must be registered with the Beltex Sheep Society. Crossbred sheep must not be listed in any Society catalogue unless they are carrying pedigree embryos. Dispersal, production and reduction sales to be held at the end of the collective sale and no sheep to be shown in the pre-sale show.
