## **Conditions of Entry and General Information**

1. All sheep entered must carry an MV Accredited Status.
2. All tags must comply with UK legislation and society rules on identification. The vendor shall be responsible for the correctness of identity.
3. All UK-bred sheep and imported sheep entered at society sales must be fully registered and all fees paid prior to sale. Any Lambs sold at foot must be Birth Notified and if sold with their dam must be fully registered by the Vendor prior to transfer.
4. Substitute Entries – there will be a cap on the number of substitute entries which will be limited to two per section. ALL substitutes to be notified via the Society Office and NOT the market. All substitutes must be notified by 12noon on Wednesday 19<sup>th</sup> May and must be marked with a red dot on the loin. NO substitutes will be allowed at the point for Arrival of Stock.
5. Scrapie genotyping is voluntary. All sheep catalogued with scrapie genotype must have valid certificates.
6. All sheep entered for Society sales must be inspected by a panel of Veterinary Officers and Inspectors appointed by the Society.
7. The inclusion of any animal in the sale following any inspection is no warranty that the animal meets any criteria or criterion in respects of any standard or will do so in future.
8. Entry Fees – £12 +VAT per lot (ie – ewe with lambs is one lot). Cheques to be made payable to Harrison & Hetherington Limited and must accompany the completed entry form and pedigrees. Entries will only be accepted if full payment is made.
9. Sale Ring Rule – any sheep which has not pass Society inspection must not be offered for sale, or advertised or promoted, in the ring.
10. No animal to be sold outside of the ring before being offered for sale in the sale ring.
11. All animals MUST be sold in sale catalogue order.
12. Transfers – Any sheep to be sold at Society sales must be registered (with the exception of lambs at foot, see point 3 above) in the flock from which it is to be sold by 31st May in the year of sale.
13. Embryos - females which have been flushed and embryos recovered before sale must be declared in the catalogue and announced at the time of sale. Failure to do so will result in the purchaser having the right to return the sheep. Costs may be incurred.

**With the present restrictions applied to livestock being sold to Northern Ireland an Online Timed Auction will only be available for Northern Ireland & Republic of Ireland Breeders. All details for entry available on request – 01228 406230 (This will take place between Saturday 22<sup>nd</sup> May and Tuesday 25<sup>th</sup> May)**

## **INSPECTIONS**

1. Tags which do not comply with UK legislation and Society requirements will result in the sheep being rejected at inspection. All registered sheep must carry tags with the Society logo. Check that tags are correct at time of entry, so that replacement tags can be ordered before the sale.
2. Sheep which have failed inspection must be removed immediately from the market premises. Vendors are advised to check their animals thoroughly prior to departure from home.
3. Any animal rejected for incorrect mouth is not allowed to be entered or substituted at following Society sales.
4. Inspection will include the following points: - Tags, Teeth, Mobility Udder, Muscularity and any other points deemed necessary by Council as they see fit.
5. Inspection Standards
  - Teeth to be inspected and assessed at the discretion of the inspector/veterinary officer. No tampering is allowed.
  - Sheep should be mobile and sound.
  - Double muscling, the animal should display double-muscled gigots.
  - Udder should be correct and free of abnormalities.
  - Fleece should be tight. A medium fleece may be acceptable.

**Specific Rules for 2021 re COVID-19 Government Guidelines and Restrictions** Due to keeping in line with Government Social Distancing rules and to avoid congestion on the dock, the inspection this year will be slightly different.

The vet will be present to watch vendors arrive and will do random pen inspections at his discretion. Checking of the catalogue against lot numbers will be done by the Inspector once the animals are penned.

The Vets decision is final.

### **Acceptance of stock:**

The arrival of stock can only be accepted onto the market premises within the time period stated in the sale catalogue. Any alteration will be notified to all vendors, however we request that all arrival times must be strictly adhered to when published in the catalogue.

All Sales will be held under the present government guidelines, there will be restrictions applied to both vendors and purchasers attending the markets during these sales. With the guideline information changing on a regularly, the details of the restrictions to attend the sales will be announced nearer to the scheduled dates.

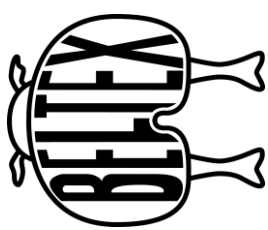
