## **REGULATIONS & CONDITIONS OF ENTRY**

1. The show and sale will be held subject to the Rules and Regulations of the Blue Texel Sheep Society, the Conditions of Sale as recommended by the LAA and the Auctioneers Standard Conditions of Sale.
2. Entry is open to any full Member of the Society provided their subscriptions are up to date. All sheep must be from Registered Flocks. All females **MUST BE FULLY REGISTERED.**
3. Entry is open to MAEDI-VISNA flocks only. All relevant documentation must accompany all sheep. The animal must be bona fide the property of the vendor at time of entry as well as time of sale.
4. Genotyping is voluntary.
5. All entries must be made on the official entry forms (attached) and must be completed in all respects. Entries must be accompanied by the ENTRY FEE and the relevant Society REGISTRATION CERTIFICATES. Entries will not be accepted if the relevant fees and certificates are omitted.
6. One substitute per section, per vendor permitted, which must be notified to the auctioneers **five days prior to the sale**, marked clearly with a red dot on the centre of the back.
7. Vendor entry - Maximum of 10 females per class, capped at an overall total of 18 females entered
8. **PRE-SALE INSPECTION** All sheep forward for the sale will be subject to a Society inspection. Any animal which does not reach the Inspection standard will not be eligible for show or sale. The inspection decision will be final and any animal failed will be removed from the sale and forfeit the entry fee.
9. Once inspected, an animal must remain in the sale yard until offered for sale.
10. A transfer fee of £5 per sheep is payable by the purchaser and paid to BTSS
11. The purchaser shall have no right to claim damages from the vendor in respect of indirect or consequential loss such as (but not limited to) loss of profit or any other loss whatsoever.
12. All sheep will be sold in guineas with a commission rate of 5%.
13. A Society Levy of 1% will be deducted from the vendors account and paid to BTSS.
14. All animals will be sold to a minimum bid of 200gns.
15. All Sheep should be scanned with the results either entered on the entry form or announced at the time of sale.
16. All entries must be made on the official entry forms (attached) and must be completed in all respects. Entries must be accompanied by the **ENTRY FEE** and the relevant Society **REGISTRATION CERTIFICATES**. Entries will not be accepted if the relevant fees and certificates are omitted.

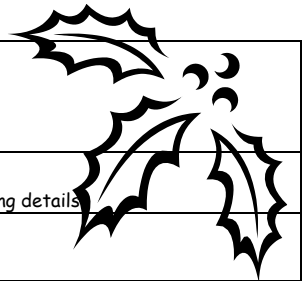
