**REGULATIONS FOR AND CONDITIONS OF SALE**

1. All animals entered must be put up for auction, and sold in the order in which they appear in the catalogue. Animals to be catalogued in order of age, the oldest to be placed first. Animals not presented in the sale ring in the catalogue order will not be admitted to the sale ring until the end of the section of the sale for which they are entered.
2. The pedigree, history and description of each animal shall be guaranteed and warranted to be correct in all particulars by the person whose name appears as vendor, but every animal shall be sold subject to all faults. No liability whatsoever is undertaken by the auctioneers for the statements appearing in the catalogue. The vendors who supply such statements are alone responsible for any error of misstatement.
3. Vendors must provide competent persons to take charge of their stock up until the close of the sale, whether sold or unsold
4. The animals will be sold in guineas. Commission of five pence for each guinea will be charged on all sales, either public or private.
5. No animal to be sold outside of the ring before being entered in the sale ring.
6. Should any animal pass out of the sale ring unsold, and be subsequently sold privately, the purchaser shall pay the commission on such private sales.
7. Animals will be offered subject to a reserve price.
8. No money shall be paid to the vendor of any lot sold, unless the lot be cleared by purchaser, and the auctioneers will not be answerable for any deficiency that may arise on the resale of any unclaimed property, but will give the vendor all reasonable assistance to have the contract enforced.
9. The purchaser to give their names and addresses in writing and pay the full purchase money for each lot at the fall of the hammer (if required), in default of which the lot, or lots, so purchased may be put up again immediately for resale.
10. No lot, or lots, shall be removed from the premises till paid for, but each and every lot shall immediately at the fall of the hammer, be considered delivered, and be, and remain in every respect at the absolute risk of the respective purchaser or purchasers thereof and shall be removed from the place of sale at the purchasers expense.
11. No undertaking of the auctioneers, or their servants, to take charge of the lots or animals after the sale, or to forward them to their destination, shall be help impose upon the auctioneer and legal obligation, or vitiate any of the forgoing regulation for the condition of sale.
12. Should any question arise, not provided for in the forgoing rules, regulations or conditions, the decisions of the auctioneers shall be final, from which there shall be no appeal.

## **ADDITIONAL CLUB SHOW & SALE RULES**

1. Each vendor is allowed 2 entries in each pre-sale show class.
2. All sheep will be sold in guineas – upset price 200gns £25 appeal against an inspection decision – if any exhibitor feels the need to Appeal against an inspection decision they can do so to the Chief Inspector or Society Secretary (if present). They will lodge a deposit of £25.00 to the Club Treasurer (refundable if appeal is successful) and the sheep will then be inspected by an appeals team of three people elected prior to the sale including a vet (if available). The decision of the appeals committee is final.
3. Sheep failing inspection must be removed immediately from the mart.
4. Tags - all sheep must comply with DARD tagging requirements and with the official Society tag, and all tags must be in place **BEFORE** entry to the mart.
5. Transfer fees - It is the vendors responsibility to have male sheep transferred to their flock.
6. All sheep to be back stamped **BEFORE** entry to the mart.
7. Substitutes - all substitute sheep should be notified to the Show / Sale Secretary, Libby McAllister (M: 07709 376361 or E: libsmca@yahoo.co.uk), not later than Thursday 28<sup>th</sup> September, and must carry a small red dot on the loin between the hips.

### **38 Female sheep not described as In Lamb**

#### **38.1 Vendor's warranty**

The Vendor warrants that a female sheep not described in any catalogue for sale or at the time of sale as In Lamb is not In Lamb at the time of sale. This warranty is a **14 Week + 5 Day Warranty**.

#### **38.2 Purchaser's rights**

If the **Purchaser** proves a breach of warranty then, at the Purchaser's option, either the **Purchaser** may exercise his rights under Schedule 6, or the Vendor shall pay to the **Purchaser as Liquidated Damages** a sum equal to the amount in paragraph (i) of the Appendix. Notice of a claim must be supported by a **Veterinary Surgeon's Certificate** or a slaughterhouse manager's or other competent person's certificate confirming that the sheep was **In Lamb**

### **39 Female sheep described as correct**

### **39.1 Vendor's warranty**

The **Vendor** warrants that all female sheep described in the catalogue or at the time of sale as correct are sound in mouth and udder, that is they are not lacking any of the 8 broad teeth and do not have any damaged or worn teeth or a defective udder. This warranty is a **5 Day Warranty**.

### **39.2 Purchaser's rights**

If the **Purchaser** proves a breach of warranty then, at the Purchaser's option, either the **Purchaser** may exercise his rights under Schedule 6, or the **Vendor** shall pay to the Purchaser as **Liquidated Damages** a sum equal to the amount in paragraph (i) of the Appendix. Notice of a claim must be supported by **Veterinary Surgeon's Certificate**.

## **40 Female sheep proving barren**

### **40.1 Vendor's warranty**

The **Vendor** warrants that any female sheep sold as being In Lamb is In Lamb at the time of sale. **This warranty is a 21 Day Warranty**.

If the **Purchaser** proves a breach of warranty he may exercise his rights under Schedule. Notice of a claim must be supported by a **Veterinary Surgeon's Certificate**.

## **43 Stock rams**

### **43.1 Vendor's warranty**

The **Vendor** warrants that any ram sold as a stock ram for the amount in paragraph (j) of appendix or more is capable of natural service. This warranty lasts from the day of sale to the **15th December** in the year of the sale.

### **43.2 Purchaser's rights**

If the **Purchaser** proves a breach of warranty the **Purchaser** may return the ram to the **Vendor** who shall, at the Purchaser's option, either replace the ram with another ram of equal value which is capable of natural service, or refund the purchase price together with such other costs and charges as the **Purchaser** may be entitled to under these Conditions.

For the avoidance of any doubt if the Purchaser is able to obtain viable semen from the ram for use by artificial insemination he shall not be entitled to any claim against the **Vendor for breach of warranty**
