By completing this entry form you are agreeing to have your sheep inspected by a Society appointed Inspector at this sale.

CONDITIONS OF ENTRY AND GENERAL INFORMATION

- All UK-bred sheep and imported sheep entered at Society sales must be fully registered and all fees paid prior to the Sale.
- All sheep entered must carry an MV Accredited Status.
- All tags must comply with UK legislation and Society rules on identification. The vendor shall be responsible for the correctness of identity.
- ALL SHEEP FORWARD FOR SALE WILL BE INSPECTED AND SCANNED UPON ARRIVAL TO THE MARKET**
Pregnancy Scanning – all sheep will be scanned at time of Inspection. If any ewe or gimmer is found not to be in lamb these will be rejected from the sale. If any empty ewe lamb is found to be in lamb these will be rejected from the sale.
- Substitutes must be declared to the Society within 48 hours prior to the sale and must be marked with a red dot on the loin.
- Scrapie genotyping is voluntary. All sheep catalogued with scrapie genotype must have valid certificates (whether NSP or Private test).
- All sheep entered for Society sales must be inspected by a panel of inspectors appointed by the Society. The inspection decision will be final, and must be removed immediately from the market premises and forfeit the entry fee.
- Any Dispersal, Production or Reduction Sales will be held at the end of the collective sale. The inclusion of any animal in the sale following any inspection is no warranty that the particular animal meets any criteria or criterion in respect of any standards or will do so in the future.
- Entry Fees - £12 + VAT. Cheques to be made payable to Harrison & Hetherington Limited and must accompany the completed entry form and pedigrees. Entry forms – Entries will be returned if certificates are not included.
- Sale Ring Rule – Any sheep which has not passed Society inspection must not be offered for sale, or advertised or promoted, in the ring.
- Transfers – Any sheep to be sold at Society sales must be registered in the flock from which it is to be sold by 31st May in the year of sale.
- Inspection – All sheep forward must be back-stamped with the lot number, failure to do so will result in rejection.
- Embryos - Females which have been flushed and embryos recovered before sale must be declared in the catalogue and announced at the time of sale. Failure to do so will result in the purchaser having the right to return the sheep. Costs may be incurred.
- Joint entries are not allowed. All members to enter their own sheep and be balloted individually.
- No double entries are allowed.

Acceptance of Stock: Due to DEFRA regulations the arrival of stock can only be accepted onto the market premises within the time period stated in the sale catalogue. Any alteration will be notified to all vendors, however we request that all arrival times must be strictly adhered to when published in the catalogue.
