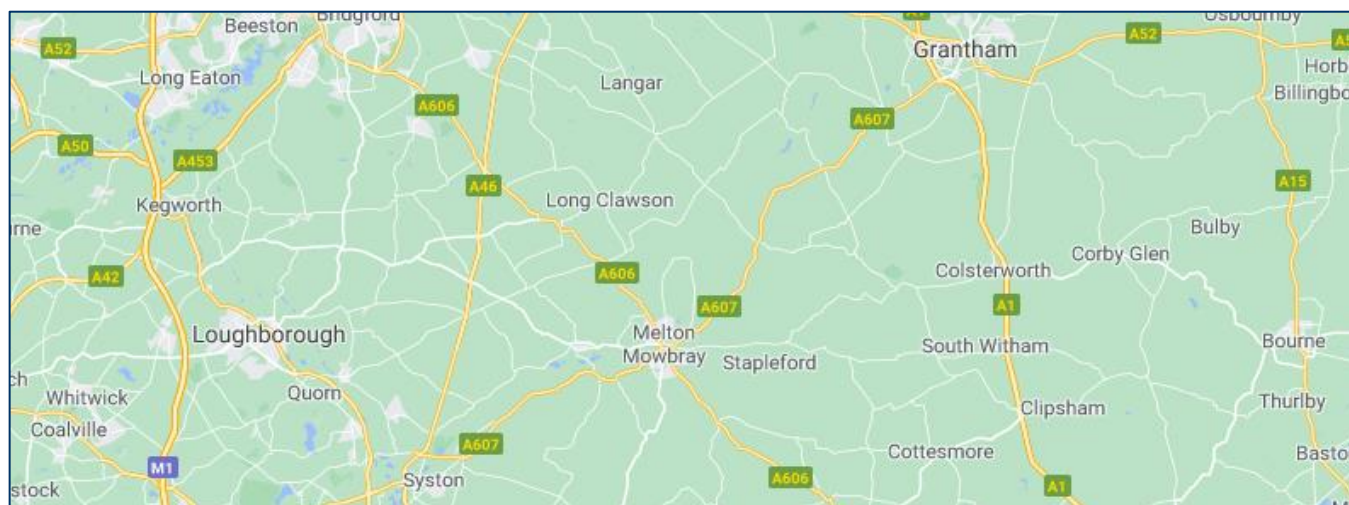

LAA REGULATIONS AND CONDITIONS OF SALE: The Sale will be held subject to the LAA (Livestock Auctioneers Association) Rules, Regulations & Bye Laws. All sheep will be sold under the Livestock Auctioneers Terms & Conditions of Sale. The Official Blue Texel, Charollais and Beltex Sales will also be held under the respective Breed Society Sale Rules. All Pedigree Blue Texel, Charollais and Beltex sheep are sold with a vendor's warranty; full details of the warranties are available from the respective Breed Society.

METHOD OF SALE: All pedigree sheep will be sold in Guineas (105 Pence) and strictly in catalogue order unless any alterations are announced by the auctioneers. Commercial sheep will be sold in £'s/head.

REGISTRATIONS: All pedigree livestock in the sale are registered with the respective society and all lambs sold with ewes will be fully registered prior to the sale.

COMMISSION, BUYERS PREMIUM & SOCIETY LEVIES: All pedigree sheep will be sold in the Guinea with a commission of 5% and on commercial sheep will be 5%. Society levies will be charged at the normal rate.

TRANSFER FEES: For the Blue Texel Society and the Beltex Society, the transfer fee will be £5 per life. For all other breeds, please contact the respective society for more details.

ONLINE BIDDING: Online bidding is available for all pedigree stock sold through the ring via Marteye: Log onto <https://meltonmowbraymarket.marteye.ie/> for further details to register.

****Please register no later than 48 hours prior to the sale****

PRE-SALE INSPECTION: All Pedigree Blue Texel, Beltex and Dutch Spotted sheep forward for the sale will be subject to a Society Inspection. Any animal which does not reach the Inspection standard will not be eligible for sale. The Inspection decision will be final and any animal failed will be removed from the sale and forfeit the entry fee. No appeal is permitted. All sheep must have ear tags to comply with current ministry regulations. Neck ties can be worn and backstamping is not necessary for this sale.

SETTLEMENT AND CLEARANCE OF STOCK: Settlement in full is due immediately at the close of Sale. No animal may leave the Sale Premises without an official 'Pass Slip', obtainable only from the Auctioneers upon settlement.

RESERVE PRICES: Vendors shall have the right to accept the final bid for their animals.

VENDORS WARRANTY AND PURCHASERS' RIGHTS:

Vendor's warranty

The Vendor warrants that, unless stated to the contrary in any catalogue for the sale or at the time of sale, in a Lot in which the ewes are described as with lamb or with lambs at foot, every ewe is suckling one or more lambs, and every lamb has a mother in the Lot. This warranty is a 5 Day Warranty.

Purchaser's rights

If the Purchaser proves a breach of warranty he may exercise his rights under Schedule 6 in respect of any ewe which does not have a lamb or any motherless lamb.

STRAW: Straw will be provided by the auctioneers.

BIOSECURITY NOTICE:

- Excessive dirty vehicles will not be allowed entry, therefore ensure vehicle is clean before arrival.
- All vehicles transporting livestock will be subject to a documentation check before entry to market site.
- All visitors and traders must ensure they wear clean clothing and footwear before entering the market site.
- All visitors and traders using car park areas please use main entrance.
- Hauliers and farmers delivering livestock must disinfect their boots before and after loading or unloading.
- Livestock purchased or unsold will not be allowed to move unless an authorised "pass slip" has been issued by the main office.

4. PRE-SALE INSPECTION: All sheep forward for the sale will be subject to a Society inspection. Any animal which does not reach the Inspection standard will not be eligible for show or sale. The inspection decision will be final and any animal failed must be removed immediately from the sale and forfeit the entry fee. No appeal is permitted.
5. A Society Levy of 1% will be deducted from the vendors account and paid to the Blue Texel Sheep Society.

1. All animals entered must be fully registered and on the Grassroots Database, with all fees paid at least 7 working days before the date of sale entry.
 2. All sheep will be sold in guineas (105 pence) and in catalogue order unless alternation is announced by auctioneer. A market commission of **marts rate** will be charged on all sheep sold as well as a further 1% levy, which will be paid to the DSSS. Entries are limited to 10 animals per consignee in any one section. All UK and imported sheep must be fully registered and fees paid prior to entry to a sale
 3. The sale is held subject to the Livestock Auctioneers Association Conditions of Sale and the Rules of the DSSS.
 4. PRE-SALE INSPECTIONS – For all official Society sales, the Society shall appoint an inspector and representatives from the Society to help with administration of inspections. The inspector will consider the DSSS inspection criteria which are listed below, and is empowered to disbar any animal which in his/her opinion does not meet the necessary standard to be sold at an official Society Sale. Any animal failing inspection will not be allowed to be sold on the day of the sale, nor any other Society sale in the same year. Such an animal will be marked with a YELLOW DOT ON THE LOIN and should, where possible be removed from the market, or penned in designated lairage away from sheep passed inspection. No advertising, promotion or sale of such a sheep is allowed on market premises. Any sheep withdrawn from a sale, passing inspection and gone through the ring but unsold will be allowed to enter subsequent Society sales but will be have to be presented for inspection again. The inspector's decision is final and neither the Inspectors, the Society nor the auctioneers will be liable to the owners of such animals or any other person or company for damage or any loss arising from such a rejection. Runs will be balloted.
- The lot number must correspond with the number entered in the catalogue. Animals without the correct identification will be rejected from the sale.
 - The animal is not suffering from any infectious disease.
 - Teeth to be assessed whereby the any incisor teeth that are felt beyond the pad, as demonstrated by catching on fingers when running from the pad downwards, or when they are so far beyond the pad that they do not catch the finger.
 - Testicles should be of even size, move freely and free from abnormalities. Ram lambs aimed scrotal circumference is 28cm. Shearling Rams 33cm
 - Udder should be correct and free from abnormalities
 - Mobility sheep should be mobile and sound with no feet and/or leg structural issues. Any animal which does not reach the inspection standard will not be eligible for sale.
 - Compliance all sheep must be registered with the official Society "Dutch Spotted Sheep Society". All sheep must be tagged in accordance with the rules of the DSSS and the relevant Government regulations.

5. The minimum upset price is set at 300gns for pedigree lots. Graded lots have an upset of 200gns.
6. Sheep unsold but passing inspection will be allowed into subsequent Society Sales but not on the same day.
7. All sheep from MV Accredited flocks will only be accepted into the market and penned for sale if they are accompanied by a current Maedi Visna Accreditation Scheme Certificate which has been correctly completed.
8. All entries must be identified by their catalogue number by means of a neck tie or by numbers printed clearly on the animals back in paint and will be sold in catalogue order.
9. All substitute entries MUST BE NOTIFIED to the Secretary not less than 7 working days before the sale . Substitute entries must be marked with a RED DOT ON THE SHOULDER. Substitutes are limited to 1 per vendor per class/section. Females can only be substituted by another female of same age and class, as is the case for males. Animals not notified to the secretary in the allotted time will be refused entry into the sale.
10. in full is due immediately at the close of sale. No animal must leave the sale premises without an official "pass slip" obtainable only from the Auctioneers upon settlement.
11. As of the 1st January 2021, the rules for exporting sheep from the United Kingdom to Northern Ireland and the European Union have changed. – NO DIRECT EXPORT OR VENDOR RETURNS WILL BE AVAILABLE. IT WILL BE THE RESPONSIBILITY OF THE PURCHASER AND/OR VENDOR TO MAKE THE NECESSARY ARRANGMENTS FOR SHEEP GOING TO NORTHERN IRELAND.

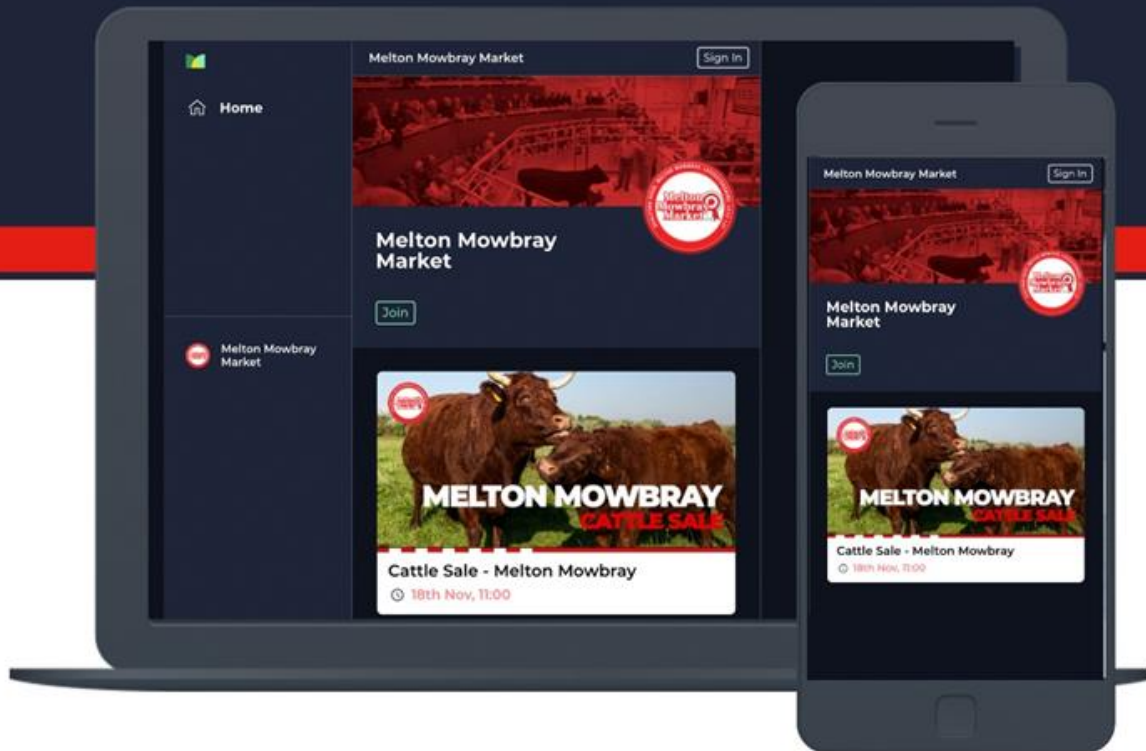
